16 S. Park Avenue; Punky's Pub Old Style sign - request for historical sign designation

Request to discuss and provide a preliminary conclusion that the sign at 16 S. Park Avenue meets the criteria for designation as a historical sign. (DISTRICT #1)

Commissioners discussed the memo and preliminary materials for historical sign designation of 16 S. Park Avenue. Commissioner Mueller noted the evidence that the sign is an iconic Chicago sign. Commissioner Zabela asked if the sign was in good working order. Mr. Fitzharris responded that he thought the sign is in good condition. Commissioner Zabela asked staff if maintenance was allowed for historical signs. Ms. Urish responded that any electrical work or face change of the sign would require a building permit and a determination by staff if the work is maintenance. A face change would impact the historical nature of the sign and would be referred to the Local

Landmark Committee and Historic Preservation Commission for a certificate of appropriateness. Commissioner Zabela asked if the internal light that appears to have an amber glow be part of the historic nature of the sign. Ms. Urish responded that a condition of approval could specify the sign's appearance.

On a motion made by Commissioner Zabela and seconded by Commissioner Sulla to find the sign at 16 S. Park Avenue merits consideration for designation as a historical sign and recommends the Historic Preservation Commission approves for a preliminary finding and to schedule a public hearing for further consideration.
