SUBJECT: RECOMMENDATION TO FILL VACANCIES ON ECDC COMMITTEE

The purpose of this memo is to provide a recommendation to the Village Board on the appointments to the ECDC Committee. Thank you for your efforts in communicating the current vacancies and calling for new applicants across the community. As a Village Trustee I truly enjoy the opportunity to meet with citizens that are interested in serving the community and getting involved on a volunteer level.

As noted in my prior memo of July 30, I did take the time to personally schedule conversations with multiple residents that submitted application forms and expressed interest in serving on the committee. The group was highly qualified and represented a broad cross section of people that live in the Village of Lombard. The talent pool was deep, and, for those who were not recommended, their names should remain on file for future opportunities.

As to the current vacancies, I am recommending that the following person be submitted to the Village Board for formal appointment to serve the ECDC:

**Nick Agliato** – Mr. Agliato is a 37 year resident of Lombard. He has a professional and educational background in Finance with 30 plus years of experience. He has also been involved locally in school PTA organizations, Knights of Columbus, Lions Club and as a Glenbard East booster.

In addition, in accordance with Section 30.23D of the municipal code, I am seeking to appoint the following person as a Non-Voting Advisory member to the committee.

**Zolanda West** – Ms. West is a 2 year resident of the Village. She has experience in local government though volunteering at the congressional level. In addition, she has been involved at the community level with local YWCA organizations.

A copy of the application submitted by each person is attached for your reference. Please note that all personal information has been redacted for privacy purposes as this memo will be posted on an agenda for public viewing.

At this time, I still have one (1) remaining vacancy to fill which was created by the recent increase in membership from 8 to 9. I intend to interview additional applicants and make a recommendation in the near future.

Again, thank you for your coordination and efforts to ensure an open and transparent process for the filling of vacant volunteer positions. I would respectfully ask that this item be placed on next Village Board agenda for formal consideration.
