BACKGROUND/POLICY IMPLICATIONS:

Tereneo 3634 LLC d/b/a Bat 17 did not fully complete the Liquor License Renewal process for the new licensing term, July 1, 2022 – December 31, 2022. Tereneo 3634 LLC d/b/a Bat 17, located at 2770 S. Highland Ave., 102, currently holds a Class "C" liquor license. During the renewal period of the new licensing term, July 1, 2022 – December 31, 2022, the licensee did not fully complete the renewal process.

The licensee informed the Village on October 3, 2022, that Bat 17 no longer conducts business at 2770 S. Highland Ave., 102, effective August 2022.

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE NUMBER
OF AVAILABLE LIQUOR LICENSES IN THE
CLASS "C" LIQUOR LICENSE CATEGORY**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE
VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor licenses, contained therein, to read as follows:

Class "C" – 8

SECTION 3: That the decrease in the number of Class "C" liquor licenses as set forth in Sections 1 above is a result of Tereno 3634 LLC d/b/a Bat 17 no longer conducting business at 2770 S. Highland Ave, 102.

SECTION 4: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
