BACKGROUND/POLICY IMPLICATIONS:			
The Police Department is seeking approval from the Village Board to enter into a three-year agreement with Flock Group, Inc. for the procurement of a solar powered video surveillance trailer as well as technical services (remote viewing, etc) and support. This trailer would replace the solar powered video surveillance trailer that the police department has currently from LiveView Technologies (LVT). The agreement with LVT expires in May of 2026. Year 1: \$30,000 Year 2: \$20,000 Year 3: \$20,000 A solar powered video surveillance trailer in included in the Police Department's FY26 budget. Grant funds from the Illinois Attorney General's Organized Retail Theft Crime Grant will cover \$15,000 (50%) of the cost of the trailer and related services in year one. Trailer and Services

As you are aware, in May of 2023 the Village Board approved a three-year agreement with Live View Technologies (LVT) for mobile solar powered video surveillance trailer services. The goal was to use the trailer for applications including but not limited to:

- Privately sponsored community events such as carnivals, and festivals
- Publicly sponsored community events such as Cruise Nights, etc.
- Areas that may need temporary monitoring of a higher vigilance level such as locations experiencing vehicle burglaries or street racing.

The annual amount paid to LVT for these services has been \$29,316.00 per year This agreement is set to expire in May of 2026.

The video trailer program has been quite successful over the term of the agreement in terms of application. It has enabled the police department to monitor special events as well as monitor areas experiencing patterns of criminal activity such as car burglaries, etc.

The police department has not been completely satisfied in terms of the equipment and service provided by LVT. When the trailer was delivered it showed some signs of weathering and prior use. There have been a few instances where relatively small repairs have been required, and it has taken LVT longer than expected to have the repairs completed. In at least one instance, the trailer could not be deployed until the repairs were completed. In addition to those issues, police department personnel have found the software to not be user friendly and somewhat difficult to navigate.

Based upon this, police department personnel investigated other potential vendors. One of the vendors was Flock Group Inc., which provides a solution that is substantially the same solution as LVT with some additional advantages.

The trailer offered by Flock offers the following features:

- 3 Cameras (2 PTZ, 1 Panoramic)
- Flashing lights for visibility and active deterrence
- Speaker
- Visual alerts to enhance suspect vehicle identification
- People detection alerts to detect when people may be in restricted areas during unauthorized times.
- Self-sufficient power management with ability to connect to landline
- Thirty (30) days of memory for recordings
- Remote viewing of live video or recorded video via web or app. Video from the trailer is integrated with other live Flock video cameras and license plate readers on a single web site.
- Smaller overall footprint than the LVT camera

The fact that the video feeds from the trailer are integrated with the Flock Safety platform where the other live video and license plate readers reside is extremely valuable as it allows officers who are responding to incidents to view all of these devices on one page. This makes the platform easy to use-especially from the inside of a patrol car.

The cost of the Flock video trailer is \$30,000.00 in the first year and \$20,000.00 each year after. Earlier this year, the Department was awarded an Organized Retail Crime Grant from the Illinois Attorney General's Office. This grant will cover 50% of the cost of the trailer's purchase and service in year one. It is our intention not to enter into another agreement with LVT once the current agreement expires in May. This means that we anticipate saving \$14,316 in year one (due to grant funding) and \$9,316 each year after compared to the cost of the LVT trailer. The proposed one-year agreement with Flock Group, Inc. is a three-year agreement that locks in the annual pricing described above.


Based on the above, I am requesting Village Board approval for the police department to enter into an agreement with Flock Group, Inc for the purchase of one (1) solar powered video surveillance trailer. A waiver of bids is being requested for the agreement as the Village has an existing relationship with Flock that has been beneficial to the Village and this agreement standardizes the video surveillance system as well as takes advantage of the Flock Safety software platform integration described above.




