Design Engineering

Attached please find a contract, resolution and fee schedule for design engineering services for the Craig Place & Willow Street Storm Sewer Improvements and Westmore-Meyers Road Sidewalks. The engineering design effort consists of preparing plans and specifications for the following:

• The storm sewer on Craig Place will be extended in the parkway from approximately 151 S. Craig Pl to 163 S. Craig Pl and include a parkway drain for future resident rear yard drainage connection.

• A failed storm sewer at 125 W. Willow Street will be replaced under a Public sidewalk next to a retaining wall using trenchless technology to reduce the impact to surrounding properties.

Sidewalks will be installed on both sides of Westmore-Meyers Road from
approximately Norton Street south to Roosevelt Road and on the north side of
Roosevelt Road from Westmore-Meyers Road east to Luther Avenue. The
construction of the sidewalks will be paid for using a Community
Development Block Grant. The design of the sidewalk will need to conform to
the Grant requirements. The project scope includes easement documentation if
needed.

This selection was made from the current Design Engineering Short List, which consists of five (5) firms. The proposal was sent to, and proposals received from, all five (5) firms. Upon review, it was determined that Baxter & Woodman of Itasca, is the most qualified firm to serve as design engineer for this project.

The scope and fee were negotiated with Baxter & Woodman and agreed to by both parties. The project consists of providing design and construction documents for the not-to-exceed design engineering services fee of \$28,157.00. The engineering costs will be paid for using the Capital Projects Fund.

Please present this agreement and resolution to the President and Board of Trustees for their review at their regular meeting of August 20, 2009. If approved, please return two original signed copies to Public Works-Engineering for further processing.
