2022 Pavement Marking Replacement Program

The purpose of the 2022 Pavement Marking Program is to replace deteriorated and damaged pavement markings. The Village evaluates the markings to determine the areas in need of marking improvements. The Village has determined the 2022 areas should focus on school crossings, Grace Street (parking stalls from Sunset Avenue to Prairie Avenue), Maple Street (Finley Road to Main Street), Madison Street (Main Street to Addison Avenue), St. Charles Road (I-355 bridge to Westmore-Meyers Road) and Westmore-Meyers Road (St. Charles Road to Roosevelt Road).

DuPage County opened bids for a County-wide project on March 4, 2022 and awarded the 2022 Pavement Marking Maintenance Program to Superior Road Striping, Inc. of Melrose Park, IL on March 22, 2022 by Resolution DT-R-0134-22. Superior included a Joint Purchase Form with their bid package to extend their bid prices to other taxing bodies in DuPage County. Attached is a schedule of pricing for this project.

Recommendation:

Last year, because of supply chain issues with paint materials, no pavement marking was done. In order to try and catch up with the work the Public Works Department is requesting an additional \$30,000 be added to the Pavement Marking Program budget. Superior Road Striping, Inc. of Melrose Park, IL has done satisfactory work for the Village in the past. Staff recommends using DuPage County's bid process to award our 2022 Pavement Marking Replacement Program to Superior Road Striping, Inc. in the amount of \$61,962.10.

APPENDIX A**VILLAGE OF LOMBARD****CONTRACT DOCUMENT NUMBER RM PROG 34**

This agreement is made this 18th day of August, 2022, between and shall be binding upon the Village of Lombard, an Illinois municipal corporation (hereinafter referred to as the "Village") and Superior Road Striping, Inc. (hereinafter referred to as the "Contractor") and their respective successors.

Witnessed, that in consideration of the mutual promises of the parties delineated in the Contract Documents, the Contractor agrees to perform the services and the Village agrees to pay for the following services as set forth in the Contract Documents:

The removal of existing pavement markings and the replacement with thermoplastic or modified urethane pavement markings consisting of various colors, sizes, and shapes. Project quantities are attached for various sections of concrete and asphalt throughout Village limits.

- School crossings/ crosswalks;
- Grace Street (parking stalls from Sunset Avenue to Prairie Avenue);
- Maple Street (Finley Road to Main Street);
- Madison Street (Main Street to Addison Avenue);
- Westmore-Meyers Road (St. Charles Road to Roosevelt Road).

1. This contract shall embrace and include all of the applicable Contract Documents listed below as if attached hereto or repeated herein:

a. Contract Document Number RM-PROG-34 for 2022 Pavement Marking Replacement Program, consisting of the following:

b. Bid Tabulation of County Awarded Schedule of Prices Dated: March 22, 2022 (attached)

c. Required Certificate(s) of Insurance.

2. The Village agrees to pay, and the Contractor agrees to accept as full payment, the amount as shown on the Contractor's Bid Proposal, which is made a part hereof, subject to such additions and deletions as agreed to by the parties hereto.

3. The Contractor shall commence work under this Contract upon written Notice to Proceed from the Village and shall complete work under this contract within 40 calendar days from the date of the Notice to Proceed. Time is of the essence in regard to this Contract, and the Contractor agrees to achieve completion within the time permitted by all proper and appropriate means including working overtime without additional compensation.
4. Pursuant to the provisions of Section 5 of the Mechanics' Lien Act of Illinois, prior to making any payment to the Contractor under this Contract, the Village demands that the Contractor furnish a written statement of the names of all parties furnishing labor and/or materials under this Contract and the amounts due or to become due each. This statement must be made under oath or be verified by affidavit. The Village shall not issue final payment nor shall any retained percentage become due until releases and waivers of lien have been supplied as the Village designates.
5. This Contract represents the entire agreement between the parties and may not be modified without the written approval of both parties.

IN WITNESS WHEREOF, the Village of Lombard, Illinois, and the Contractor have each hereunto caused this Contract to be executed by their respective duly authorized representatives this 18th day of August, 2022.
