SUBJECT: Block Party Wagons

The Village and the Park District have partnered to provide Block Party Wagons to residents of Lombard in an effort to promote community. There are currently six (6) Block Party Wagons that are maintained and managed by the Lombard Park District. The initial purchase of the wagons was made by the District through grant funding provided by the Village. These wagons vary in age but are all in need of replacement due to age and condition.

The Village has included the purchase of two (2) trailers for the Public Works Department in the 2024 budget. In an effort to secure the best pricing, the Village and District sought pricing for the Village trailers, as well as the replacement Block Party Wagons. The purchase of the trailers will be presented to the Village Board for consideration. To clearly define the responsibility of the Village and District as it relates to the Block Party Wagons, the attached Memorandum of Understanding (MOU) has been developed.

The MOU states that the purchase of the trailers will be made by the Village with the trailers titled to the Lombard Park District. Upon delivery of the trailers, the District will be responsible for the management, maintenance and repair of the trailers. The District will also be responsible for the purchase and maintenance of the contents of the trailers. The agreement states that the Village and District will work to replace the trailers on a ten-year basis.

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (the "Agreement") is entered into this ____ day of April 2024, by and between the VILLAGE OF LOMBARD, an Illinois non-home rule municipal corporation (the "Village") and the LOMBARD PARK DISTRICT, a body corporate and politic and unit of local government of the State of Illinois (the "District").

WITNESSETH

WHEREAS, the Village and the District encourage residents to get to know each other and to foster positive neighborhood activities for families and friends.; and

WHEREAS, the Village and the District have partnered to provide six (6) Block Party Wagons ("Wagons") to the public free of charge; and

WHEREAS, the Village has funded the initial purchase of the Wagons, and the District has assumed ownership and maintenance responsibility for the Wagons; and

WHEREAS, the District has been responsible for the purchase and maintenance of the contents of the Wagons, which generally includes tables, 100 chairs, a 10'x10' canopy, large charcoal grill, a bean bag game and a sound system; and

WHEREAS, the Village and District have determined that the Wagons should be replaced on a ten (10) year rotation so that the Wagons are in good working order; and

WHEREAS, the Village and District agree that the Village shall continue to fund the purchase of the Wagons and that the District shall be responsible for all maintenance and operation of the Wagons; and

NOW, THEREFORE, in consideration of the mutual undertakings herein set forth, and other good and valuable consideration, the Village and the District agree as follows:

1. The foregoing recitals are made a part hereof and incorporated herein.
2. The Village will purchase the Wagons and will have said Wagons titled in the Lombard Park District's name upon purchase.
3. The District will be responsible for the purchase of the contents of the Wagons, including the installation of logos on the exterior of the Wagons.
4. The District agrees the Wagons will be insured under the District's insurance program and that any claim that arises out of the use of the Wagons shall be covered by the District's insurance policies.
5. The District will be responsible for the delivery and pick-up of the Wagons in accordance with District policies.

IN WITNESS WHEREOF, the Village, pursuant to authority granted by the adoption of a Resolution by its Board of Trustees, has caused this Agreement to be executed by its President and attested by its Clerk; and the District, pursuant to authority granted by the adoption of a

[Motion/Resolution] by its Board of Park Commissioners, has caused this Agreement to be signed by its President and attested by its Secretary.
