

**SUBJECT:** **Motion to Approve Plat of Easement (Public Utilities and Detention) and Acceptance of Public Improvements (Water Main) at 448 W North Avenue (Lombard Cold Storage)**

The Community Development Department recommends that the Board of Trustees approve the Plat of Easement for Lombard Cold Storage (448 W North Avenue). The easements granted provide the Village with access to inspect the stormwater detention basins, and to access and operate the water main and fire hydrant constructed to serve the building.

The Community Development Department also recommends that the Board of Trustees accept the water main and fire hydrant in the dedicated water main easement at 448 W North Avenue. The valve vault is located in the public right-of-way. The sanitary sewer and storm sewer installed on the property will remain under private ownership.

The stated improvements are acceptable since they were installed substantially to plan and passed all required tests. The Private Engineering Services Division has approved the project record drawings. Please contact me with any questions.
