Resolution for the Obligation of Funds

The current Capital Improvement Plan (CIP) includes the North Grace Street Roadway Improvements project, which is programmed for construction in Fiscal Year (FY) 2026.

The project limits extend from East St. Charles Road to North Avenue (IL Route 64). The scope of work includes roadway base repairs and resurfacing, curb and gutter replacement, minor storm sewer additions, adjustments and repairs, pavement markings, installation of a bike lane/route, and ADA-compliant improvements to sidewalks, ramps, and crosswalks.

The bid documents have been prepared in accordance with Illinois Department of Transportation (IDOT) procedures and guidelines for Federal-Aid projects, including all applicable requirements related to contract documents.

Attached is a resolution (IDOT Form BLR 05310C) that documents the Village's funding obligation for its portion of the total construction project budget. This resolution is a component of the Joint Funding Agreement for Federally Funded Construction, which is being submitted to IDOT in coordination with the final plans and specifications for the April IDOT bid letting.

Please present this resolution to the President and Board of Trustees for their consideration at the regular meeting scheduled for January 22, 2026. Upon approval, please return three (3) original signed copies of the agreement to Public Works–Engineering for further processing.

WHEREAS, the above stated improvement will necessitate the use of funding provided through the Illinois Department of Transportation (IDOT); and signee

WHEREAS, the use of these funds requires a joint funding agreement (AGREEMENT) with IDOT; and

WHEREAS, the improvement requires matching funds; and

Section 1: The Village of Lombard hereby appropriates \$1,049,000.00 or as much as may be needed to match the required funding to complete the proposed improvement from local funding and furthermore agree to pass a supplemental resolution if necessary to appropriate additional funds for completion of the project.

Section 2: The Village of Lombard Village President is hereby authorized to execute an AGREEMENT with IDOT for the above-mentioned project.

Section 3: This resolution will become Attachment 3 of the AGREEMENT.

Section 4: The Village Clerk of Lombard is directed to transmit 2 (two) copies of the AGREEMENT and Resolution to IDOT District 1 Bureau of Local Roads and Streets.
