**Overhead Sewer Grant Funding** 

Due to the flooding caused by the April 18<sup>th</sup> storm, resident participation in the Overhead Sewer Grant program increased significantly this fiscal year. The FY13 budget, Water/Sewer Capital Reserve Fund, allocated \$50,000 to the Overhead Sewer Grant program. June of 2013 an additional \$120,000 was reallocated to this program for a total of \$170,000 available to meet the increased demand. To date the Village has paid out approximately \$168,000. Additionally, grants totaling approximately \$60,000 have been approved but have not been submitted for reimbursement. However, because of the length of time since their approval staff does not anticipate that many of them will be submitted for reimbursement during the remainder of FY13. Currently, the Department has four (4) pending reimbursement requests that were recently submitted totaling \$10,718.50 which would bring the total expenditures to \$178,513.46.

I respectfully request that the Board of Trustees allocate an additional \$30,000.00 to this program to fulfill the pending, and any additional, reimbursement requests that are submitted through December 31, 2013.
