ORDINANCE NO. 4982

AN ORDINANCE GRANTING A VARIATION PURSUANT TO TITLE 15, CHAPTER 155, SECTION 212 OF THE LOMBARD ZONING ORDINANCE

(ZBA 01-11: 429 S. Craig Place Lombard, Illinois)

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore adopted the Lombard Zoning Ordinance, otherwise known as Title 15, Chapter 155 of the Code of Lombard, Illinois; and,

WHEREAS, the subject property is zoned R2 Single Family Residence District; and,

WHEREAS, an application has been filed requesting approval of a variation to the Zoning Ordinance to allow a 48 inch high open deck in a front yard setback where a 36 inch high deck would be allowed on the property described in Section 2 below,

WHEREAS, a public hearing on such application has been conducted by the Village of Lombard Zoning Board of Appeals on May 23, 2001 pursuant to appropriate and legal notice; and,

WHEREAS, the Zoning Board of Appeals has filed its recommendations with the President and Board of Trustees recommending denial of the variation described herein; and,

WHEREAS, President and Board of Trustees have determined that it is in the best interest of the Village of Lombard to approve the requested variation.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That a variation is hereby granted for the property described in Section 2 below from Title 15, Chapter 155, Section 212 of the Village of Lombard Zoning Ordinance so as to allow a 48 inch high open deck in a front yard setback where a 36 inch high deck would be allowed.
