SUBJECT: Ordinance Amending Title XI, Chapter 112, Section 112.13(A) - Alcoholic

Beverages - Taqueria Los Comales Lombard - 719 E. Roosevelt Road

Licensee, Mezcal Mexican Restaurant Corp. d/b/a Taqueria Los Comales Lombard, located at 719 E. Roosevelt Road, currently holds a Class "U" liquor license.

The Class "U" allows Alcoholic beverages to be served as an adjunct to food service; no package sales allowed. A service bar, with no more than ten seats at the bar, shall be allowed. Video gaming, as provided for under the Illinois Video Gaming Act, shall not be allowed on the licensed premises.

Village staff has been notified in December 2024 that the ownership interest in Mezcal Mexican Restaurant Corp. has changed by selling 50 percent of the ownership interest to another party in December 2017. The licensee was originally issued a Class "U" liquor license at the October 5, 2017, Board of Trustees meeting as Mezcal Mexican Restaurant Corp. d/b/a Mezcal Mexican Restaurant, located at 719 E. Roosevelt Road and later to change the business name to Taqueria Los Comales Lombard, February 15, 2018.

Village Code Title XI, Chapter 112, Section 112.20(D) states that a liquor license shall terminate whenever 50 percent or more of the ownership interest changes from that shown on the original license application.

The original owner of Mezcal Mexican Restaurant Corp sold the remaining 50 percent of the ownership interest to the owner of the remaining 50 percent, effective January 15, 2025. The new owner of Mezcal Mexican Restaurant Corp. at 100 percent ownership interest, has made an application for a new Class "U" liquor license.

Attached is an ordinance decreasing and increasing the number of Class "U" licenses by one to reflect the ownership interest changes.

Staff is requesting a waiver of first reading to reflect these changes.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "U" liquor license category, contained therein, to read as follows:

Class "U" - 0

This decrease in the number of Class "U" liquor licenses reflects the sale of 50% of the business in 2017 by the owner of Mezcal Mexican Restaurant Corp d/b/a Mezcal Mexican Restaurant located at 719 E. Roosevelt Road in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "U" liquor license category, contained therein, to read as follows:

Class "U" - 1

This increase in the number of Class "U" liquor licenses reflects the issuance of a Class "U" liquor license to Mezcal Mexican Restaurant Corp d/b/a Taqueria Los Comales Lombard, who will be operating the business, under its new ownership at 100% of Mezcal Mexican Restaurant Corp, commonly known as Taqueria Los Comales Lombard, located at 719 E. Roosevelt Road, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect on February 6, 2025, and after its passage and approval as required by law.
