SUBJECT: **Request for a Class “O” and Class “A/B-II”-Liquor License
LOIL Associates LLC d/b/a Embassy Suites Chicago, Lombard, Oak Brook
LOIL Associates LLC d/b/a Stacks Grilled Cheese & Bar
707 E. Butterfield Road**

The Village received notice that a receiver had been appointed in relation to the Embassy Suites Chicago Lombard Oak Brook property located at 707 E. Butterfield Road. The receivership order grants the court-appointed Receiver possession and control of the property and authorizes the Receiver to retain LOIL Associates LLC as property manager/operator for the property. The Receiver has requested that LOIL Associates LLC be permitted to apply for new local liquor licenses for the continued operation of Embassy Suites Chicago Lombard Oak Brook and Stacks Grilled Cheese & Bar.

The primary function and business model for both licensed establishments will remain the same. Embassy Suites Chicago Lombard Oak Brook will continue to operate as a hotel, and Stacks Grilled Cheese & Bar will continue to operate as the restaurant/bar establishment located within the hotel property.

Attached are ordinances amending Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code to decrease and then increase the number of available Class “O” and Class “A/B-II” liquor licenses by one. These amendments reflect the termination of the licenses previously issued to Lombard Hospitality Management, LLC and the proposed issuance of new licenses to LOIL Associates LLC, as applicant/operator pursuant to authority granted by the court-appointed Receiver and the receivership order entered in DuPage County Case No. 2026 FC 000047.

The petitioner is requesting a waiver of first reading so that the license applications may proceed.

ORDINANCE _____

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN
REGARD TO ALCOHOLIC BEVERAGES**

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class “A/B-II” liquor license category, contained therein, to read as follows:

Class “A/B-II” – 7

This decrease in the number of Class “A/B-II” liquor licenses reflects the termination of the Class-“A/B-II” liquor license previously issued to Lombard Hospitality Management, LLC d/b/a Stacks Grilled Cheese and Bar for the licensed premises located at 707 E. Butterfield Road, Lombard, Illinois

Section 2: That Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class “A/B-II” liquor license category, contained therein, to read as follows:

Class “A/B-II” – 8

This increase in the number of Class “A/B-II” liquor licenses reflects the issuance of a Class “A/B-II” liquor license to LOIL Associates LLC d/b/a Stacks Grilled Cheese and Bar, which will operate the licensed establishment at 707 E. Butterfield Road, Lombard, Illinois, pursuant to authority granted by the court-appointed Receiver and the order entered in DuPage County Case No. 2026 FC 000047.

Section 3: This Ordinance shall be in full force and effect on **July 1, 2026**, and after its passage and approval as required by law.
