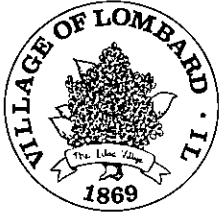

On Monday, May 5, 2008, bids were opened for the 2-year (FY 2009/2010 and FY2010/11) Total Landscape Maintenance Contract. Bid specifications were sent to twelve (12) vendors, of which two (2) bidders' responded and all met the Village specifications.

The Low Bidder was The TLC Group Ltd. The bid results are below.

The Public Works Department is recommending that a 2 year contract be awarded to the TLC Group for the FY 2009 and FY2010 Total Landscape Maintenance Contract in an amount not to exceed \$76,457.30.
