

ORDINANCE NO. 8136

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112 OF THE
LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES AND
THE CREATION OF A NEW CLASS “N” LIQUOR LICENSE SUBCATEGORY “N-IV”
AND AUTHORIZING ONE NEW CLASS “N-IV” IN RELATION THERETO**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.12(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class “N-IV” liquor license category, to read in its entirety as follows:

“Class “N-IV” – Alcoholic beverages served in relation to a “Restaurant – Sit-Down” (as defined in Section 155.802 of this Code), with the food service constituting at least 80 percent of the gross income of the establishment. The gross dollar amount of annual sales of the establishment shall be no less than \$1,500,000.00. The gross square footage of the restaurant building shall be no less than 7,000 square feet. Package sales of wine by the bottle only shall be allowed, but only as sold to customers ordering a meal for consumption on-premises or off-premises. Video gaming, as provided for under the Illinois Video Gaming Act, shall not be allowed on the licensed premises.”

SECTION 2: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by adding language relative to new Class “N-IV” liquor license thereto, which shall read in its entirety as follows:

“Class “N-IV” – 1”

The creation of one new Class “N-IV” liquor license reflects the issuance of a Class “N-IV” liquor license to Olive Garden Holdings, LLC d/b/a The Olive Garden Restaurant #6473, located at 86 Yorktown Shopping Center, Lombard, Illinois.

SECTION 3: That Title XI, Chapter 112, Section 112.14(A) of the Lombard Village Code is amended by adding language thereto, relative to a new Class “N-IV” liquor license category, which shall read in its entirety as follows:

“Class “N-IV” – \$3,000”

SECTION 4: That Title XI, Chapter 112, Section 112.17 of the Lombard Village Code is amended by creating a new Subsection (E) to read in its entirety as follows:

“(E) At least 30 days prior to any liquor license renewal date, Class N-IV Liquor License holders shall file with the Local Liquor Control Commissioner a statement under oath, accompanied by written documentation, as to the dollar amount of all sales for the previous 12 months and the dollar amount of liquor sales for the previous 12 month period, to allow a determination to be made as to whether at least 80 percent of the gross income of the restaurant came from food service and whether the dollar amount of all sales was at least \$1,500,000.00.”

SECTION 5: That Title XI, Chapter 112, Section 112.40(A) of the Lombard Village Code is amended by revising the reference therein to “A/B-II-VG, A/B-III-VG, A/B-IV-VG, D-VG, I-VG, N-I-VG, N-II-VG, N-III-VG, S-VG, XX-VG, Z-VG, A/B-I, A/B-II, A/B-III, A/B-IV, C, D, E, EE, GGG, I, K, L-I, L-II, M, N-I, N-II, N-III, O, R, S, SS, T-I, T-II, T-III, U, V, VV, X, XX and Z liquor license holders”, to read, “A/B-II-VG, A/B-III-VG, A/B-IV-VG, D-VG, I-VG, N-I-VG, N-II-VG, N-III-VG, S-VG, XX-VG, Z-VG, A/B-I, A/B-II, A/B-III, A/B-IV, C, D, E, EE, GGG, I, K, L-I, L-II, M, N-I, N-II, N-III, N-IV, O, R, S, SS, T-I, T-II, T-III, U, V, VV, X, XX and Z liquor license holders.”

SECTION 6: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
