**Subject:** Grass and Weed Mowing Contract Renewal

On November 7<sup>th</sup>, 2019, the Village of Lombard advertised for bids for the Village contract **PWO 20-17A**, *Grass Mowing and Weed Control*. The lowest responsible bid was received from *Beary Landscape Management*. The original contract was from March 2020 through November 30, 2020 with two optional one-extensions. In April 2020, the Village exercised it right to alter the mowing frequency of several sites and new prices were established for those sites.

Staff has contacted *Beary Landscape Management* and they have agreed to accept the year two renewal option at the prices agreed to in April 2020 for the 2021 calendar year. *Beary Landscape Management* provided good service to the Village over the past year and responded in a timely manner when there have been areas of concern.

Staff recommends renewing the Grass and Weed Mowing contract with *Beary Landscape Management* for the amount of \$61,400.00. This is the first of two possible one-year extension of the contract and will expire December 31, 2021. Please present this item to the Board of Trustees at the November 19, 2020 meeting for their approval.
