The Village has received a request for a Class “A/B-III” liquor license from Gia Mia Lombard, LLC d/b/a Gia Mia, located at 310 Yorktown Shopping Center, for the remainder of the current license term January 1 - June 30, 2025.

Gia Mia is a full-service restaurant with a farm-to-fork food concept offering a wide range of Italian dishes with a complimenting wine list. This location is the seventh for this type of concept and the 14th dining location for the parent company, BG Hospitality Group, LLC. Other Gia Mia locations include Elmhurst, Wheaton, Geneva, St. Charles, Downers Grove, and Naperville.

Attached is an ordinance increasing the Class “A/B-III” liquor license category by one and issuing a liquor license to Gia Mia Lombard, LLC d/b/a Gia Mia, located at 310 Yorktown Shopping Center.

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13 OF THE
LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF
CLASS “A/B-III” LIQUOR LICENSES**

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein, relative to the Class “A/B-III” liquor license category, to read in its entirety as follows:

“A/B-III” – 10”

This increase in the number of Class “A/B-III” liquor licenses reflects the issuance of a new Class “A/B-III” liquor license to Gia Mia Lombard, LLC d/b/a Gia Mia, located at 310 Yorktown Shopping Center, Illinois.

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
