Subject: Zoll AutoPulse Unit Purchase

The Lombard Fire Department is seeking a recommendation from the Public Safety and Transportation Committee to purchase Four Zoll AutoPulse Units.

This purchase will allow the Firefighter/Paramedics to effectively provide the level of care to our patients for a greater chance of survival while reducing the risks of provider injury, during cardiac arrest incidents.

The cost for Four AutoPulse Units and equipment is approximately, \$67,759. The Foreign Fire Tax Board agreed to a 50% cost sharing measure, not to exceed, \$35,000. This will ease the cost burden to the Village and is a benefit to our first responders.

Incorporating this device into resuscitative efforts is necessary as our mission is to preserve life.

Attached is a memo for your review on the CPR Data update, previously shared with the Village Manager. This will give some additional insight before the next Public Safety and Transportation Committee meeting and will help initiate questions or concerns.

Subject:	CPR Data Update

Purpose:

To provide insight into the limitations of manual CPR and support the purchase of the Zoll AutoPulse.

Background:

Our goal is always to provide the highest quality of care to our patients. Despite our best efforts manual CPR is often ineffective. Incorporation of the Zoll AutoPulse device will provide automatous CPR resulting in a 30-40% increased likelihood of achieving Return of Spontaneous Circulation (ROSC) during cardiac arrest (Gao,2016). Obtaining ROSC is, "the most crucial factor contributing to survival and favorable neurological outcomes following Out-of-hospital Cardiac Arrest (OCHA). Survival is believed rare without pre-hospital ROSC for OCHA victims." (Xiong, 2016).

Discussion:

CPR with minimal interruption is critical to preservation of life. Despite the valiant efforts of bystanders and Paramedics, the national average for ROSC is about 9%. In Lombard, we responded to 46 cardiac arrests in 2019, and achieved ROSC in 5 cases (9.2%). Our success is in line with the national average, but there are clear avenues for improvement and a greater chance of survival.



Data captured during recent CPR events in Lombard show that we are seldom providing our patients with compressions that meet American Heart Association (AHA) recommendations. We are only providing CPR 71% of the time; 29% of the time there are no compressions being delivered. The AHA recommends pauses less than 5 seconds; 42% of our pauses were over 10 seconds in duration. We train to minimize pauses, but long pauses, some stretching beyond two minutes, are unavoidable when the patient is being carried to the stretcher.



Also, when we are delivering compressions, this data shows that we are most often compressing too rapidly and too shallow. We are compressing at the proper depth 19% of the time, we are at the proper rate 25% of the time. Ideally, we should deliver the proper rate and depth at the same time, this is a rare feat that we achieve only 8% of the time.

The consistent mechanical coordination needed to maintain perfusion is an extremely difficult process to choreograph effectively even under ideal conditions. Fluctuations of rate, depth, and interruption of CPR beyond five seconds all have adverse effects on perfusion. This is where automated external CPR calibrated for each patient based on their weight and chest circumference is clearly superior and directly tied to improved rates of survival with neurological preservation.

Studies indicate that we only achieve 29% of normal blood flow to the heart muscle with standard CPR and Epinephrine (Halperin, 2004). With the AutoPulse providing consistent high-quality compressions, we can achieve 100% of pre-arrest perfusion to the heart and brain when combined with Epinephrine (Halperin, 2004). Incorporating the AutoPulse into our resuscitation protocol will ensure uninterrupted CPR, and advance the quality and effectiveness of the care we provide to the community. Due to this improved rate of perfusion provided by AutoPulse, ROSC has been achieved in 40-50% of cardiac arrests (Gao, 2016).

Besides the obvious benefits for the patient, the device may also be effective in reducing the risk of injury while lifting and moving the patient. The AutoPulse was designed with an integrated carrying sling that is easily deployed beneath the patient's legs and torso. The sling has many handles which allow the whole team, usually five providers, to participate in lifting and carrying the patient. The AutoPulse continues to provide compressions while the patient and defibrillator are neatly packaged within the sling. This makes negotiating stairs, hallways, and uneven terrain safer and more effective. The improved ergonomics and a distributed load are effective at reducing the risk of injury due to strain and poor body mechanics.
