The work described in this Additional Work Authorization (AWA) is outside of the original scope of work anticipated for the professional service contract between Engineering Resource Associates, Inc. (ERA) and the Village of Lombard (Village). ERA will proceed as expeditiously as possible to complete the described services upon written authorization.

Reason(s) for Services:

The Design Engineer's proposed Geotechnical Engineer cannot complete the necessary boring and soil analysis on time, so the Village asked the Design Consultant to seek a proposal from SEECO Consultants, another firm on the Village's shortlist. SEECO found that underground utilities, private property, and wetlands limit the available equipment to obtain borings at the required depth, requiring a specialized and more time-consuming method. SEECO recommends additional soil testing to detect potentially harmful chemicals that may prevent the disposal of construction spoils as clean material. A laboratory will be used for chemical soil testing, and the results will be provided on the standard IEPA form.

The original change work order included a \$6,200 quote from Rubino Engineering. SEECO Consultants quote is \$8,670. This amount is \$2,470 more than the original change work order limit.

SCOPE OF WORK

Task 3 - Geotechnical Borings and Report

SEECO Consultants Inc. will provide soil borings and analysis for the structural retaining wall design. Their contract and scope of work are attached. Items include:

- 2 soil boring samples at 15-20' depth
- Soil boring logs
- Geotechnical report
- CCDD testing and certification.
