Class "ZZ"—Package sales of beer and wine only, as an adjunct to a convenience store with gasoline sales which, at the time of said convenience store's annexation to the village, had a valid DuPage County liquor license.

After the decrease in the number of available Class “ZZ” licenses to “0”, at the February 16, 2023 Board of Trustees Meeting and further review with staff and the Village Attorney, it is recommended to delete the Liquor License Class “ZZ” in its entirety.

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 112,
SECTIONS 112.12(A), 112.13(A) and 112.14(A)
OF THE LOMBARD VILLAGE CODE IN
REGARD TO LIQUOR LICENSE CLASS “ZZ”**

BE IT ORDAINED by the President and Board of Trustees of the
Village of Lombard, DuPage County, IL as follows:

Section 1: That Title XI, Chapter 112, Sections 112.12(A), 112.13(A), and
112.14(A) of the Lombard Village Code are hereby amended by deleting the Liquor
License Class “ZZ”, and all references thereto, in their entirety.

Section 2: This Ordinance shall be in full force and effect from and after its passage
and approval as required by law.
