Attached is an ordinance amending the Lombard Village Code Alcoholic Beverages Sections 112.12(A), 112.13(A), and 112.14(A) relative to the Liquor License Class "ZZ".

Class "ZZ"—Package sales of beer and wine only, as an adjunct to a convenience store with gasoline sales which, at the time of said convenience store's annexation to the village, had a valid DuPage County liquor license.

After the decrease in the number of available Class "ZZ" licenses to "0", at the February 16, 2023 Board of Trustees Meeting and further review with staff and the Village Attorney, it is recommended to delete the Liquor License Class "ZZ" in its entirety.

Staff is requesting a waiver of first reading in order to bring the Village Code current.
