Witnesseth That in consideration of the mutual promises of the parties delineated in the Contract Documents, the Contractor agrees to sell and the Village agrees to pay for the following described items as set forth in the Contract Documents:

The contractor is to remove of all existing roofing to the roof deck. The contractor will then replace any T & G Decking found too be damaged at an additional cost of \$10.00 per LF. The contractor is to then install Ice and Water Shield and roofing felt. They will then construct the Cupola/Clock Tower and install on roofing felt. They will then replace all fascia with 4": cedar (to be painted by others) and shingle with 30-year Arch. shingles all work as explained on proposal dates October 30, 2008 (attached).

- 3. Risk of loss, destruction or damage of or to goods under this Contract shall be on contractor until delivery of the goods to the Village and acceptance of the goods by the Village.
- 4. Contractor agrees to perform the terms of this Contract from January 1, 2009 Time is of the essence of this Contract.
- 5. Where the terms of this Contract conflict with the provisions of the Contract Documents, the Contract Documents shall be binding.

- 1. Remove existing 1 layer of existing shingles.
- 2. Replace damaged 2 x 6 T&G decking at the rate of \$ 10.00 per LF.
- 3. Provide and install W.R. Grace Ice & water shield per the following:
 - 2 36" courses along eaves
- 4. Provide and install #30lb.underlayment on remaining roof deck.
- 5. Provide and install new 4" cedar fascia painted by others.
- 6. Provide and install 64"x 64" 18ga. metal framed cupola per plans.
- 7. Provide and install cement board wall sheathing.
- 8. Provide and install 8"x 8" aluminum baby tins at cupola
- 9. Provide and install aluminum roof to wall flashing at cupola. (black)
- 10.Provide and install thin brick veneer. (standard colors)
- 11. Provide and install aluminum soffit and fascia at cupola.
- 12. Provide and install 7" seal tab starter course on eaves and rake ends.
- 13 Provide and install GAF Timberline 30 year laminated shingles.
- 14. Install lead plumbing vent flashings provided by others.
- 15. Provide and install new pre-finished masonry counter flashing.
