BACKGROUND/POLICY IMPLICATIONS:

The FYE 2020 final budget amendment request for the following is attached:

- 1) Increase of \$679,802 to the Capital Projects fund. The increase is for expenditures for the reimbursement of \$2,500,000 to the LPFC in regards to Ordinance #7855 RDA.
- 2) Increase of \$417,682 to the Water and Sewer O&M Fund. The increase is for the following items:
 - a. \$367,737 over budget for Glenbard Wasterwater treatement services, based on actual flow in 2020.
 - b. \$37,134 paid to Robinson Engineering for Village Engineer, originally budgeted in 2020 in the W&S Capital Reserve Fund (Legistar #20010).
 - c. \$16,699 over budget for gas for lift/pump stations.

Section 2: That these amendments should reflect the actual expenses for the fiscal year and will increase the total amount of the budget by \$1,097,484.

Section 4: Additional funds are available to effectuate this revision.

<u>Section 5:</u> That this ordinance shall be in full force and effect after the passage and publication pursuant to the laws of the State of Illinois and the Village of Lombard.
