

SUBJECT: Ordinance Amending Section 50.039 of the Lombard Village Code

Section 50.039 of the Village Code provides regulations for the discharge of industrial waste discharges into the Village's sanitary sewer system. The amendment proposed reflects changes in the established local limits for specific chemicals. The Village Code was amended in 2019 and a local limit for hexavalent chromium was inadvertently left in the revised code. This amendement is intended to clean-up the Ordiannce that was adopted in 2019.

Based upon a review by the USEPA, it has been determined that the Village Code should not contain a local limit for hexavalent chromium, as this is not a chemical that is prevalent in the Village nor does the Glenbard Wastewater Authority (GWA) issue permits for the discharge of hexavalent chromium. Additionally, the Ordiannce amendment provides clarity on the local limits imposed on the PH limit. Therefore, there is no regulatory or other requeirement to establish a local limit. The elimination of the local limit and clarification on PH limit will bring the Village and GWA into full compliance with the EPA permits. The proposed changes are as follows:

## § 50.039 Limitations on certain discharges.

Discharges from each separate discharge of a user, as measured under the provisions of this Chapter, shall not contain in excess of the following concentrations based upon a 24-hour composite sample, or from a grab sample, where indicated. Multiple industrial wastewater discharges from a permitted facility may be combined in a flow weighted manner to determine compliance with the following limitations.

# AN ORDINANCE AMENDING TITLE V, CHAPTER 50, SECTION 50.039 OF THE LOMBARD VILLAGE CODE IN REGARD TO LIMITATIONS ON CERTAIN DISCHARGES FOR INDUSTRIAL WASTEWATER PRETREATMENT STANDARDS AND REQUIREMENTS

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard,

DuPage County, Illinois, as follows:

**SECTION 1:** That Title V, Chapter 50, Section 50.039 of the Lombard Village Code is hereby amended in its entirety as follows:

### "§ 50.039 Limitations on certain discharges.

Discharges from each separate discharge of a user, as measured under the provisions of this Chapter, shall not contain in excess of the following concentrations based upon a 24-hour composite sample, or from a grab sample, where indicated. Multiple industrial wastewater discharges from a permitted facility may be combined in a flow weighted manner to determine compliance with the following limitations.
