Included in the current year budget is a replacement for a unit in the Police Investigative division. Due to the unit being used for surveillance purposes, advertising is inappropriate and state bid for this type of vehicle won't be out until January. Deputy Chief Cuny expressed the need for the vehicle sooner. Therefore, I recommend the B.O.T. waive bid and purchase one 2006 sedan from the dealer who normally is awarded the state contract. The price for this vehicle is comparable to last years state bid contract price. Budgeted amount for this purchase is \$21,500. Purchase price is \$16,238.
