Recommendations from the Transportation and Safety Committee

At the October 3, 2005, Transportation and Safety Committee meeting, the committee recommended the following items:

- Prohibit parking on the north side of Washington Boulevard from the east curb line of Westmore-Meyers Road to the west curb line of Addison Street.
- Post the east side of Highland Avenue "No Parking, 8 Am 5 PM, Monday Friday" from St. Charles Road to a point 145 feet south.
- Post the west side of Highland Avenue "No Parking, 8 Am 5 PM, Monday Friday" from St. Charles Road to a point 255 feet south.
- Post 5th parking stall south of St. Charles Road on South Park Avenue on the east side 30-minute parking.

The following sections of the traffic code require an ordinance:

Schedule VII – Parking Prohibited at all Times on Certain Streets

Add: North side of Washington Boulevard from the east curb line of Westmore-Meyers Road to the west curb line of Addison Street

Add New Schedule: Schedule VIII (s) – Parking Prohibited During Certain Hours on Certain Streets (s) In accordance with Section 10-13-3 and when signs are erected giving notice hereof, no person shall park a vehicle in any of the following places during the hours of 8:00 A.M. to 5:00 P.M., Monday through Friday:

Add: Highland Avenue, east side, from the south curb line of St. Charles Road to a point 145 feet south.

Add: Highland Avenue, west side, from the south curb line of St. Charles Road to a point 255 feet south.

Add New Schedule: Schedule X (p) - Parking Time Limited on Certain Streets

(p) In accordance with Section 10-13-10, and when signs are erected giving notice thereof, no person shall park a vehicle for a period of time exceeding 30 minutes.

Add: Park Avenue, east side, 5Th parking stall south of St. Charles Road.

ORDINANCE AMENDING THE LOMBARD TRAFFIC CODE

WHEREAS, the President and Board of Trustees of the Village of Lombard have heretofore passed and approved Ordinance 1186, An Ordinance Regulating Traffic in the Village of Lombard (hereinafter the Lombard Traffic Code); and

WHEREAS, the President and Board of Trustees of the Village of Lombard find that the Lombard Traffic Code has been amended from time to time; and

WHEREAS, the Transportation and Safety Committee has reviewed the appropriate traffic studies and recommends certain changes to the Lombard Traffic Code; and

WHEREAS, the Corporate Authorities of the Village of Lombard concur in the recommendation of the Transportation and Safety Committee.

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

Section 1: That Schedule VII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS be amended to add the following thereto:

Washington Blvd.	East curb line of Westmore-Mevers Rd.	West curb line of Addison St.

Section 2: That Schedule VIII of the Lombard Traffic Code (Ordinance 1186) entitled PARKING PROHIBITED DURING CERTAIN HOURS ON CERTAIN STREETS (s) be amended to add the following thereto:

(s) In accordance with Section 10-13-3 and when signs are erected giving notice hereof, no person shall park a vehicle in any of the following places during the hours of 8:00 a.m. to 5:00 p.m., Monday through Friday:

Highland Avenue East side	South curb line of St. Charles Road	A point 145 feet south
Highland Avenue West Side	South curb line of St. Charles Road	A point 255 feet south

(p) In accordance with Section 10-13-10 and when signs are erected giving notice hereof, no person shall park a vehicle for a period of time exceeding 30 minutes:
