**SUBJECT:** **Text Amendment to Title XI, Chapter 121, Section 121.03A.(2)  
Number of Public Passenger Licenses**

Village Code Title XI, Chapter 121, Section 121.03 states that all taxicab operators providing services within the Village shall be required to secure a business license prior to commencing such services.

People Cab Co., Inc. (“People Cab & Limo Company”), d/b/a People Cab & Limo, located at 200 30th Avenue, Bellwood, Illinois, previously held a Public Passenger License to operate within the Village of Lombard. A review of Public Passenger License records indicates that the required renewal applications for the July 1, 2022 – June 30, 2023, term and all subsequent terms were not submitted. Staff contacted the owner, who confirmed that People Cab & Limo has not conducted business within the Village of Lombard for the past several years.

Attached is an ordinance amending Title XI, Chapter 112, Section 121.03A.(2) decreasing the number of Public Passenger Licenses from three (3) to two (2) due to the non-renewal of the aforementioned licensee.

Staff is requesting a waiver of first reading in order to reflect the current number of public passenger licenses.

**ORDINANCE \_\_\_\_\_**

**AN ORDINANCE AMENDING TITLE XI, CHAPTER 121,  
SECTION 121.03A.(2) OF THE LOMBARD VILLAGE CODE IN  
REGARD TO PUBLIC PASSENGER LICENSES**

**BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES  
OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS** as follows:

Section 1: That Title 11, Chapter 121, Section 121.03A.(2) of the Lombard Village Code is amended to read as follows:

**(2) Number**

There shall be two (2) Business Licenses issued by the Village. No additional Business Licenses shall be issued unless approved by the Board of Trustees.

Section 2: That the change in the number of Public Passenger Licenses set forth in Section 1 above, is a result of the voluntary non-renewal of the license by:

People Cab Co., Inc. (People Cab & Limo Co.) d/b/a People Cab & Limo, 200 30<sup>th</sup> Avenue, Bellwood, IL 60104.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
