SUBJECT: Request for a Class "K" Liquor License

Signature Banquet Hall - 415 E. North Avenue

As you are aware, on March 5, 2020 the Village Board approved a development proposal for a Holiday Inn Express located at 415 E. North Avenue. As part of that development and located immediately to the west of the proposed hotel site is the former Casey's banquet facility which has been remodeled and is now known as Signature Banquet Hall.

Staff received a request for a Class "K" liquor license from the owners of Signature Banquet Hall which would allow the onsite consumption of alcoholic liquor by patrons of the banquet hall facility only and does not allow the sale of alcoholic liquor to the general public.

Attached is an ordinance increasing the Class "K" liquor license category by one and issuing a liquor license to Lombard Banquet Hall Inc. d/b/a Signature Banquet Hall effective December 1, 2020.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: Effective December 1, 2020, that Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "K" liquor license, contained therein, to read as follows:

Class "K" - 3

This increase in Class "K" liquor licenses reflects the issuance of a Class "K" liquor license to Lombard Banquet Hall, Inc. who will be operating the business commonly known as Signature Banquet Hall located at 415 E. North Avenue, Lombard.

<u>Section 2:</u> Effective December 1, 2020 this Ordinance shall be in full force and effect from and after its passage and approval as required by law.
