Subject: Roadway Lighting LED Replacement Project

Bid specifications were sent to the Master Intergovernmental Cooperative Purchasing Agreement (MICPA) with U.S. Communities Government Purchasing Alliance. Currently 497 communities in Illinois are participating in U.S. Communities Government Purchasing Alliance. The U.S. Communities Government Purchasing Alliance is a program that affords member communities an opportunity to participate in a program whereby a service or commodity is publically bid by a Lead Agency and the results of that competitive solicitation is available to all 90,000 public agencies. The Village used the same process for roofing projects on the Police Department, Village Hall and Public Works buildings. Graybar Electrical submitted the winning bid to US Communities for electrical supplies and fixtures. The bid results are as follows:



This project consists of retrofitting 132 new LED street lamps fixtures in the existing Cobra head roadway lights. These components will be removed and replaced with 58-watt LED fixtures. A list of suggested lights to be part of this project is attached. Staff estimates an annual savings from electrical usage and maintenance costs of \$14,644.00. This project has been pre-approved to participate in the ComEd Energy Efficiency Program and will be eligible for a rebate up to \$10,775.00 and an additional 25% bonus of \$2,693.7 if project can be completed by December 2, 2020. The total cost of the project after the full rebate amount would be \$16,326.76. The return on the investment would be approximately 13 months.


The areas that are part of this replacement project include; Pinebrook subdivision, Collen subdivision, Foxworth subdivision, north on 22nd and west of Main St., north of Roosevelt and west of Main St. and east of Westmore and south of Madison St.

Staff recommends approving the purchase of 132 LED light fixtures from Graybar Electrical through the US Communities contract in the amount of \$29,795.46.
