The Village received a request for a Class "E" liquor license from Swim MGR, LLC, the new owners of Glass Court Swim and Fitness Club, located at 830 E. Roosevelt Road for the remaining January 1 – June 30, 2026, licensing term.

The previous owners of Glass Court Swim and Fitness closed its doors, at the end of March 2025, after serving the Lombard Community for more than 40 years. The new owners are looking to keep the same footprints as previous with the exception of Video Gaming.

Glass Court is a full-service, family-friendly, health club and offers a variety of exercise and recreational options with a paid membership fee.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE NUMBER OF CLASS "E" LIQUOR LICENSES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the language therein, relative to the Class "E" liquor license category, to read in its entirety as follows:

"E" – 1"

This increase in the number of Class "E" liquor licenses reflects the issuance of a new Class "E" liquor license to Swim MGR, LLC d/b/a Glass Court Swim and Fitness Club, located at 830 E. Roosevelt Road, Lombard, IL.

SECTION 2: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
