SUBJECT: Everbridge Mass Notification System

Attached is a three-year contract for the Everbridge Mass Notification System provided by Everbridge, Inc. This is a mass notification system that offers the ability to quickly disseminate critical information to residents during emergencies such as natural disasters, public safety threats, and severe weather conditions. Messages can be sent through multiple channels including SMS, email, and voice calls, ensuring broad reach.

The Everbridge Mass Notification System addresses the limitations of previous methods by allowing users to opt-in while also offering the capability to push out messages to the entire village or selected areas within the village, regardless of opt-in status. This feature ensures broader coverage and more effective dissemination of critical information. Additionally, it offers features for internal communication, which will help streamline communication for our Public Works staff, enabling efficient coordination for call-outs and routine operations.

The Community Relations Committee reviewed this tool and quote at their August 12, 2024 meeting and recommended acquiring and implementing this mass communication system. Approval of the attached contract in the amount of \$14,685.72 for the first year, \$13,035.72 for year two and \$13,035.72 for year three is recommended.
