SUBJECT: Ordinance Amending Title XI, Chapter 112, Section 112.13(A) – Alcoholic Beverages – Rock Bottom Restaurant & Brewery – 94 Yorktown

Walnut Brewery, Inc. d/b/a Rock Bottom Restaurant & Brewery located at 94 Yorktown currently holds a Class "Z" liquor license which allows alcoholic beverages to be served as an adjunct to food service at a location that also brews beer on the licensed premises. They are also allowed to sell packaged beer which is brewed on the licensed premises for carry out.

Staff has been advised that as a result of bankruptcy proceedings, there has been a change of ownership. Village Code Title XI, Chapter 112, Section 112.20(D) states that a liquor license shall terminate whenever 50 percent or more of the ownership interest changes from that shown on the original license application.

Rock Bottom Group LLC d/b/a Rock Bottom Restaurant & Brewery has made application for a new a new Class "Z" liquor license. They indicated that no changes will be made in the day-to-day operations of Rock Bottom.

Attached is an ordinance decreasing and increasing the number of Class "Z" licenses by one to reflect the ownership changes.

Staff is requesting a waiver of first reading to reflect these changes.

ORDINANCE

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "Z" liquor licenses, contained therein, to read as follows:

Class "Z" - 0

This decrease in the number of Class "Z" liquor licenses reflects the termination of the Class "Z" liquor license issued to Walnut Brewery, Inc. d/b/a Rock Bottom Restaurant & Brewery located at 94 Yorktown due to a change of ownership.

Section 2: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "Z" liquor licenses, contained therein, to read as follows:

Class "Z" - 1

This increase in the number of Class "Z" liquor licenses reflects the issuance of a new Class "Z" liquor license to Rock Bottom Group, LLC d/b/a Rock Bottom Restaurant & Brewery located at 94 Yorktown, Lombard, IL.
