

ORDINANCE AMENDING TITLE 11, CHAPTER 121, TAXI LICENSING

ORDINANCE NO. 4990

AN ORDINANCE AMENDING TITLE 11, CHAPTER 121 OF THE LOMBARD VILLAGE CODE IN REGARD TO TAXICAB BUSINESS LICENSING

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title 11, Chapter 121, Section 121.02(c) of the Lombard Village Code is amended by revising the second sentence thereof to read in its entirety as follows:

"Copies of said certifications shall be kept on file at the offices of the Business Licensee and shall be made available to the Village's Finance Department upon request."

SECTION 2: That Title 11, Chapter 121, Section 121.03(A)(3) of the Lombard Village Code is amended as follows:

- A. Subsections (d), (e), (f), (g) and (j) are hereby repealed.
- B. Subsections (h), (i), (k) and (l) are hereby re-labeled as subsections (d) through (g), respectively.

SECTION 3: That Title 11, Chapter 121, Section 121.03(A)(6) of the Lombard Village Code is amended by deleting the last sentence thereof.

<u>SECTION 4</u>: That Title 11, Chapter 121, Section 121.03(A)(7) of the Lombard Village Code is amended to read in its entirety as following:

"Unlawful to Operate Without Business License. It shall be unlawful for any Person to operate any Taxicab for hire in the Village unless:

- (a) The owner of said Taxicab is a Person holding a current Business License; and
- (b) The Taxicab and the Taxi Operator are properly insured pursuant to 625 ILCS 5/7-601."

SECTION 5: That Title 11, Chapter 121, Section 121.03(A)(8) of the Lombard Village Code is hereby repealed.

SECTION 6: That Title 11, Chapter 121, Section 121.03(A)(9)(c) of the Lombard Village Code is amended to read in its entirety as follows:

"(c) Who fails to properly insure the Taxicabs or the Taxi Operators used by said Business Licensee."

SECTION 7: That Title 11, Chapter 121, Section 121.03(A) of the Lombard Village Code is amended by re-labeling subsections (9), (10), (11) and (12) as subsections (8), (9), (10) and (11), respectively.

SECTION 8: That Title 11, Chapter 121, Section 121.03(B) of the Lombard Village Code is hereby repealed.

SECTION 9: That Title 11, Chapter 121, Section 121.03(C) of the Lombard Village Code is hereby repealed.

SECTION 10: That Title 11, Chapter 121, Section 121.03 of the Lombard Village Code is amended by re-labeling subsection (D) as subsection (B).

SECTION 11: That Title 11, Chapter 121, Section 121.04 of the Lombard Village Code is amended to read in its entirety as follows:

"§121.04 LICENSEE OBLIGATIONS.

It shall be the obligation and duty of each Person who is issued a license under this Chapter to make sure that:

- (A) All Taxicabs used by said Business Licensee are in a clean, safe and sanitary condition, and are maintained in compliance with all applicable Federal, State and Local laws, rules and regulations; and
- (B) That all Taxi Operators employed by said Business Licensee are at least eighteen (18) years of age, possess a valid State of Illinois drivers license which allows said Taxi Operator to legally operate a Taxicab and be able to speak and understand the English language sufficiently to be able to communicate with a passenger and perform the duties of a Taxi Operator."

SECTION 12: That Title 11, Chapter 121, Section 121.05(A)(2) of the Lombard Village Code is amended to read in its entirety as follows:

"(2) Insurance Policies. Every insurance policy shall provide for coverage limits in compliance with those required for motor vehicles under Illinois law."

SECTION 13: That Title 11, Chapter 121, Section 121.08(H)(5) of the Lombard Village Code is amended by deleting the following language therefrom:

"and that the Taxi Operator is eligible for reimbursement in cash for said Program coupons"

SECTION 14: That Title 11, Chapter 121, Section 121.08(H) of the Lombard Village Code is amended by repealing subsections (6) and (7).
