SUBJECT: Resolution Approving Amendment to Village Manager's Employment Agreement

Attached, please find information regarding a proposed Fifth Amendment to the Village Manager Employment Agreement between the Village of Lombard and Village Manager Scott Niehaus. It is my recommendation that the Village extend the terms of this agreement by approval of a Fifth Amendment to the agreement at the Board of Trustees Meeting on May 15, 2025.

The overall terms of the Employment Agreement will remain essentially the same with certain modifications to extend the term of the current agreement to May 31, 2029. The contract amendments recommended are either required to extend the term of the contract or provisions to update the existing contract with current terms. As there are no material changes to the proposed agreement aside from the term extension, I am recommending approval and seeking consensus of the Board regarding the Fifth Amendment to the Village Manager Employment Agreement as presented.

### FIFTH AMENDMENT TO VILLAGE MANAGER EMPLOYMENT AGREEMENT

This Fifth Amendment to Village Manager Employment Agreement (hereinafter referred to as the "Fifth Amendment"), being an amendment to the Village Manager Employment Agreement dated December 5, 2013, as amended by the First Amendment to Village Manager Employment Agreement dated July 16, 2015, the Second Amendment to Village Manager Employment Agreement dated May 18, 2017, the Third Amendment to Village Manager Employment Agreement dated March 15, 2018 and the Fourth Amendment to Village Manager Employment Agreement dated May 20, 2021, (hereinafter collectively referred to as the "Amended Agreement"), is made by and between the Village of Lombard, an Illinois municipal corporation (referred to in the Amended Agreement as the "Employer," and hereinafter referred to as the "Employer") and Scott R. Niehaus (referred to in the Amended Agreement as the "Employee," and hereinafter referred to as the "Employee"), in and for the consideration of the Employer retaining the professional services of the Employee to act as Village Manager of the Employee agree as follows:

- 1. That Section 2 of the Amended Agreement is hereby amended as follows:
  - A. The first sentence thereof is revised to read in its entirety as follows:
    - "This Agreement shall remain in effect from May 15, 2025 through and including the first Lombard Village Board meeting in May of 2029, unless terminated earlier by the Employer or Employee, said date in May of 2029 being the end of the term of office for the current Village President, Anthony Puccio."
  - B. That the references to "2025," as contained in the second and third sentences, are revised to read, "2029".
- 2. That Section 3 of the Amended Agreement is hereby amended so that reference to "2025," as contained in subsection B., is revised to read, "2029".
- 3. That Section 4.A. of the Amended Agreement is hereby amended by revising the monetary reference therein to read, "Two Hundred Fifty-Two Thousand Sixty-Eight and 13/100 Dollars (\$252,068.13)".
- 5. That all other provisions of the Amended Agreement, not amended by this Fifth Amendment, shall remain in full force and effect as if set forth herein.
