SUBJECT: Request for a Class "AB-II" Liquor License Buca Di Beppo 90 Yorktown Mall Drive

Buca Di Beppo currently holds a Class AB-II Liquor License. Its primary purpose is a "Sit Down" Restaurant establishment with the sale of full alcohol.

The Village was notified at the end of 2024 of a change in ownership and received a request, January 30, 2025, for a Class "AB-II" liquor license from the new owners, BDB Intermediate, LLC 100% ownership to BDB Other States, LLC d/b/a Buca Di Beppo, located at 94 Yorktown Mall Drive for the remainder of the January 1 – June 30, 2025, license term.

Previously, Buca, Inc held 100% ownership of Buca Restaurants 2, Inc. d/b/a Buca Di Beppo, located at 90 Yorktown Mall Drive.

Buca Di Beppo is known for its Italian cuisine and family-style dining. They have been within the Village of Lombard since 1998.

The current operations, menu, and staffing will remain unchanged as well as the hours of operations.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) decreasing and increasing the Class "AB-II" liquor license category by one relative to the new ownership, BDB Other States, LLC d/b/a Buca Di Beppo, located at 94 Yorktown Mall Drive.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13 (A) OF THE LOMBARD VILLAGE CODE IN <u>REGARD TO ALCOHOLIC BEVERAGES</u>

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "AB-II" liquor license category, contained therein, to read as follows:

Class "AB-II" – 8

This decrease in the number of Class "AB-II" liquor licenses reflects the ceasing of business by Buca Restaurants 2, Inc. d/b/a Buca Di Beppo, and the termination of the Class "A/B-II" liquor license issued to Buca Restaurants 2, Inc. in relation thereto.

Section 2: That Title 11, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "AB-II" liquor license category, contained therein, to read as follows:

Class "AB-II" – 9

This increase in the number of Class "AB-II" liquor licenses reflects the issuance of a Class "AB-II" liquor license to BDB Other States, LLC who will be operating the business, under its new owner, commonly known as Buca Di Beppo, located at 90 Yorktown Mall Drive, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
