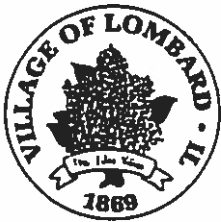

Subject: Sidewalk Snow and Ice Removal Contract Renewal

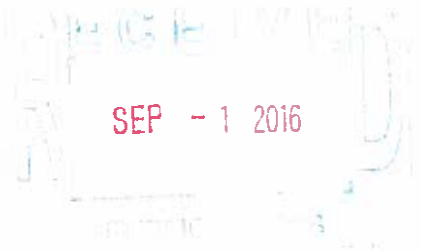
The Village of Lombard opened bids for Sidewalk Snow and Ice Removal on October 2, 2015. The lowest responsible bid was received from Beverly Snow and Ice, Inc. The Village of Lombard's current Sidewalk Snow and Ice Removal contract expired May 31, 2016. We have valued the level of service and commitment Beverly Snow and Ice, Inc. has provided to the Village of Lombard over the past year. The Village would like to exercise the option of extending the contract for an additional year under the current contract terms and conditions as specified in Contract document PWO-1516. The extension would be in effect from 12:01a.m. November 15, 2016 until 12:00 midnight, May 31, 2017.

The FY16-FY17 budget includes \$19,450.00/year for this service through accounts 101.270.310.75770 and 240.110.107.75610
