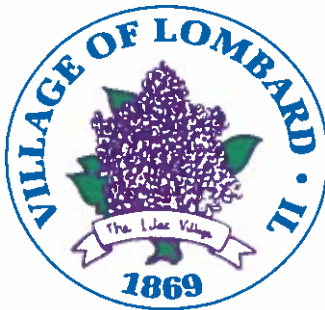


**ORDINANCE NO. 7450**

**AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES BY TERMINATING A CLASS "A/B-I" LIQUOR LICENSE AND ISSUING A NEW CLASS "A/B-I" LIQUOR LICENSE, SUBJECT TO CERTAIN CONDITIONS**

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

**SECTION 1:** That, effective December 1, 2017, Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-I" liquor license contained therein, to read as follows:

"Class 'A/B-I' – 6"

This decrease in the number of Class "A/B-I" liquor licenses reflects the voluntary non-renewal of the Class "A/B-I" liquor license issued to Johnson's Door County Fish & Shrimp Inc. d/b/a Johnson's Door County Fish & Shrimp located at 908 E. Roosevelt Road, Lombard, Illinois.

**SECTION 2:** That, subject to the Local Liquor Control Commissioner receiving written notice that LFJ, LLC has acquired Johnson's Door County Fish & Shrimp, located at 908 E. Roosevelt Road, Lombard Illinois, on or before December 18, 2017, (the "Notice"), effective with the date of said Notice, Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended as follows:

A. The language therein, relative to the Class "A/B-I" liquor license category, is amended to read in its entirety as follows:

"Class 'A/B-I' – 7"

This increase in the number of Class "A/B-I" liquor licenses reflects the issuance of a new Class "A/B-I" liquor license to LFJ, LLC d/b/a Johnson's Door County Fish & Shrimp, located at 908 E. Roosevelt Road, Lombard, Illinois, provided the Village is in receipt of the Notice on or before December 18, 2017. In the event that the aforementioned Notice is not received on or before December 18, 2017, the Lombard Village Board shall, at the December 21, 2017, Village Board meeting, pass an Ordinance specifically repealing this Section 2.

**SECTION 3:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
