MAD BOMBER FIREWORKS PRODUCTIONS – 4TH OF JULY FIREWORKS DISPLAY

Attached please find information recommending approval of a Fireworks Production Agreement with Mad Bomber Fireworks Productions for the production of a fireworks display to take place on July 4, 2018 in Madison Meadow Park.

In 2016, the Village issued a Request for Proposals (RFP) seeking qualified vendors for a computer choreographed and electronically fired fireworks production and display to take place on July 4, 2016 with a renewal option for Wednesday, July 4, 2018. Multiple pyrotechnics vendors were solicited to provide proposals for the provision of a fireworks display for the Village. A contract was awarded to Mad Bomber Fireworks Productions for 2016 with an option to renew under the same terms for 2017 and 2018.

It is the recommendation of Fire Marshal Jerry Howell to proceed with a renewal of the contract with Mad Bomber Fireworks Productions for 2018. Mad Bomber has an established history of dependability, safety, cooperation with Village and Fire Department Staff as well as a record of an enjoyable fireworks production.

Having been the fireworks vendor for the Taste of Lombard for the last decade and the vendor for the Village of Lombard display in 2015, 2016 and 2017, Mad Bomber Fireworks Productions has significant experience in Lombard at the Madison Meadow location and will provide a display of the same caliber as past years.

The proposed Fireworks Production Agreement with Mad Bomber provides for the production and display of a thirty minute fireworks display at a cost of \$35,000. The attached Resolution authorizes execution of an agreement with Mad Bomber pending development and final approval of a Fireworks Display Agreement between the Village of Lombard and the Lombard Park District.


