Number of Authorized Liquor Licenses – Class "A/B-II" Roundhead's Pizza Pub-Lombard – 275 W. Roosevelt Road

JNJS Pizza, Inc. d/b/a Roundhead's Pizza Pub-Lombard located at 275 W. Roosevelt Road currently holds a Class "A/B-II" liquor license which allows them to serve alcoholic beverages as an adjunct to food service with no packaged sales. Staff received verbal confirmation from the restaurant owner that the business has ceased operations.

Attached is an ordinance decreasing the Class "A/B-II" liquor license category by one as required by Village Code.

AN ORDINANCE AMENDING TITLE 11, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title 11, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II" liquor license category contained therein, to read as follows:

Class "A/B-II" - 8

Section 2: That the decrease in the number of Class "A/B-II" liquor licenses set forth in Section 1 above, is a result of JNJS Pizza, Inc. d/b/a Roundhead's Pizza Pub located at 275 W. Roosevelt Road no longer conducting business.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
