Text Amendments to the Village Code of Ordinances, Chapter

150.141: Inspection Fee Amendments

As part of the Village's ongoing fiscal review of development regulations and policies, the Community Development Department identified the existing fee schedule provisions for excessive inspections. This matter was reviewed by the Board of Building Appeals (BOBA) as well as the Economic and Community Development Committee (ECDC). unanimously recommended approval of a modification to the inspection fee requirements under selected instances.

Attached are the following documents for consideration:

- 1. The ECDC staff memorandum setting forth the rationale for modifying the fee schedules to account for projects that are subject to excessive re-inspections; and
- 2. An Ordinance establishing Chapter 150.141 (A) of the Village Code setting forth the building permit inspection fees for selected projects.

Text Amendment to Section 150.141: Re-Inspection Fees

As part of an overall budget review process, Village staff was directed to various department budgets in anticipation of a budget shortfall for the 2019 calendar year. The focus was to be on charging a right sized fee for services being used.

One area staff identified was re-inspection fees. While there is current code text to require a \$55.00 fee for residential re-inspections and \$68.00 for commercial inspections, Village policy has been for many years to allow the first failure with no re-inspection and only charge any reinspection fees after the second inspection has failed.

Staff has identified this as a possible source to charge for actual timed used. In real world applications, if a scheduled inspection could not be undertaken due to delays on the contractor's end, it could result in the need for an additional inspection to be undertaken. This adds additional costs to the Village, either in the form of additional staff time and resources or by the Village's private inspection services entity undertake the additional inspection (currently at a cost of \$80.00/hour).

Staff completed a survey of 13 communities to see how others handled the same issue. While some communities charged and some did not, most did reply that they charge re-inspection fees for most failed inspections with no allowance for one failed inspection.

OPTIONS AVAILABLE

- 1. Do nothing and have staff continue to not charge for the first failed inspection, but charge for subsequent failed inspections
- 2. Have staff start charging re-inspection fees for the first failed inspection
- 3. Direct staff to draft language that provides for two levels of re-inspections fees to right size the fee to actual staff time involved in the re-inspection. Such language could be drafted to apply a small fee (suggest \$25) for one or two items to be re-inspected and a larger fee (\$55 residential as currently in code and \$68 Commercial as currently in code) for re-inspections that will take staff similar amounts of time as the initial inspection.

ACTIONS TO DATE

Staff brought this matter to BOBA at their January 31, 2018 meeting. Through discussion, they unanimously proposed an alternate recommendation to the ones offered by staff above. Through their deliberation, BOBA recommends that a failed first re-inspection should not have a re-inspection fee but subsequent re-inspection fees shall be assessed a higher fee than what is currently provided within Village Code; all in an attempt to offset the cost of such re-inspections incurred by the Village (\$65 for residential and \$80 for non-residential was suggested as a possible figure).

COMMITTEE ACTION REQUESTED

Staff recommends that ECDC recommend approval of the amendments to the re-inspection fees as set forth by BOBA. Any recommendation from ECDC will also be shared with the Finance Committee prior to final consideration by the Village Board.

ORDINANCE _____

AN ORDINANCE AMENDING TITLE XV, CHAPTER 150, SECTIONS 150.141(A) AND 150.141 (X)(3) OF THE LOMBARD VILLAGE CODE IN REGARD TO BUILDING PERMIT INSPECTION FEES

WHEREAS, the Lombard Board of Building Appeals met on January 31, 2018, to consider the Village Code amendments set forth below; and,

WHEREAS, the Lombard Economic and Community Development Committee met on February 12, 2018 to consider the Village Code amendments set forth below; and,

WHEREAS, the Lombard Economic and Community Development Committee and the Lombard Board of Building Appeals have filed their recommendations with the President and Village Board of Trustees, recommending approval of the Village Code amendments set forth below;

NOW, THEREFORE, BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS, as follows:

SECTION 1: That effective January 1, 2019, Title XV, Chapter 150, current Section 150.141 (A)(4) of the Lombard Village Code shall be renumbered as Section 150.141 (A)(5).

SECTION 2: That effective January 1, 2019, Title XV, Chapter 150, Section 150.141(A) of the Lombard Village Code is hereby amended by adding a new subsection (4) thereto, which shall read in its entirety as follows:

"(4)Re-Inspection Fees. In the event that a building permit related inspection by the Village or its agents results in a failed inspection, either as a result of the construction activity not meeting code provisions, or the construction otherwise not being in compliance with the improved plans, the following additional fees shall be assessed:

- (a) First failed inspection no additional fee.
- (b) Second or subsequent failed inspections \$65.00 for a single-familty residential project and \$80.00 for all other projects.

In the event that the permittee and/or the permittee's contractor does not have the project site ready for an inspection at the time and on the date the inspection was scheduled to occur, the additional fee set forth in subsection (b) above shall be assessed."
SECTION 3: That effective January 1, 2019, Title XV, Chapter 15, Section 150.141 (X)(3) of the Lombard Village Code is hereby amended to read in its entirety as follows:
(3) Inspection of project improvements –(a) Three percent (3%) of the engineer's estimated cost of all of the public improvements, as defined in Title XV, Chapter 154, Section 154.703 of this Code.
(b) In addition to the fee set forth in subsection (a) above, Inspections conducted before 7:30 a.m. or after 4:00 p.m. on weekdays, and/or at any time on weekends and holidays, when available, shall be billed at a rate which shall be the greater of:
 (i) \$100.00 per hour of inspection time; or (ii) The actual cost billed to the Village, by a third party, for the inspection, as provided for by this Chapter 16 of Code which shall apply even if the permittee, or the permittee's authorized agent or contractor, fails to show up for a scheduled inspection.
Any inspection conducted before 6:00 a.m. or after 5:00 p.m. on weekdays, and at any time on weekends and holidays, when available, shall be subject to a two (2) hour minimum inspective time, which shall apply even if the permittee, or the permittee's authorized agent or contractor, fails to show up for a scheduled inspection."
SECTION 4: That this Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.
