Regulation of Solicitors for Funds

Attached is an ordinance amending Title 11, Chapter 118, Section 118.06 of the Lombard Village Code relative to the Regulation of Solicitors for Funds. This amendment reflects technical changes to Village Code to coincide with State Statute relative to the proper short title of the Act as it is now known (the Solicitation for Charity Act) as well as to cite the proper citation of the statute.

Village Counsel found the inconsistency between Village Code and State Statute while researching another matter and notified staff. Staff is submitting the attached ordinance for consideration at the June 21, 2018 Village Board meeting. The amendments proposed by this ordinance do not make any substantive or operational changes to solicitation regulations (e.g., hours, terms, permits).

## AN ORDINANCE AMENDING ARTICLE XI, CHAPTER 118, SECTION 118.06 OF THE LOMBARD VILLAGE CODE IN REGARD TO THE REGULATION OF SOLICITORS FOR FUNDS

**BE IT ORDAINED** by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 118, Section 118.06 of the Lombard Village Code is hereby amended as follows:

- (A) The reference to "An Act to Regulate Solicitation and Collection of Funds for Charitable Purposes Providing for Violations Thereof, and Making an Appropriation Therefor (225 ILCS 460/1)," as contained therein, is revised to read, "the Solicitation for Charity Act (225 ILCS 460/0.01 et seq.)."
- (B) The reference to "§ 5.56.030," as contained therein, is revised to read "§ 118.03."

**SECTION 2:** That this Ordinance shall be in full force and effect from and after its passage, approval and publication is pamphlet form, as provided by law.
