Construction Observation (Resident Engineering) Contract

Overview

The Westmore-Meyers Road Resurfacing and Path Crossing Improvements project replaced the Westmore-Meyers Road Safety and Bicycle/Pedestrian Improvements project which is included within the current 2018-2027 Capital Improvement Program. The Village secured federal alternative transportation funding for this project through the DuPage Mayors and Managers Conference. The construction project budget is \$1,900,000 (\$1,423,000 federal funds, \$477,000 Village funds), and \$220,000 is budgeted for construction observation (resident engineering services) with Village funds. The project is scheduled for construction in fall 2018. Westmore-Meyers Road intersects two regional trails (Illinois Prairie Path and Great Western Trail).

Project Summary

The project will improve both path crossings on Westmore-Meyers Road and resurface the project limits between St. Charles Road and Roosevelt Road. No lane reallocation, modification, reduction, or "road diet" is included in the project, and the federal funding has been retained. Improvements along Westmore-Meyers Rd include the following items:

- Realignment of the Great Western Trail crossing to utilize the signalized St. Charles Rd intersection, high visibility crosswalk, and signal improvements
- Improve the Illinois Prairie Path crossing with a curb extension within the existing SB striped area and high visibility crosswalk with beacons
- Optimize existing signal timings between Highridge Rd and St. Charles Rd
- Asphalt resurfacing between Roosevelt Rd and St Charles Rd

These improvements also complement the 2018 Traffic Signal Modernization Program, since traffic signal equipment between Highridge Rd and St. Charles Rd will be improved in summer 2018. The Village has negotiated the project construction observation contract scope/fee with Thomas Engineering Group for \$158,644.67, and the fee remains within the approved CIP amount.

Recommendation

Staff recommends that the Village Board approve the construction observation contract in accordance with staff recommendation.
