SUBJECT: Ordinance Amending Title XI, Chapter 123, Section 123.04(A) - Raffles

Written Rules

Village Code Title XI, Chapter 123, Section 123.04(A) places certain restrictions on the conduct of raffles. Currently there are seven restrictions a raffle licensee must abide by. After discussing this section of Village Code with Village Counsel, it was recommended that a new subsection (8) be added which would require a licensee to prepare and maintain a written set of rules which are applicable to the conducting of the raffle and shall provide these written rules, upon request, to anyone who desires to purchase a raffle chance.

Attached is an ordinance prepared by Village Counsel amending Village Code Title XI, Chapter 123, Section 123.04(A) adding a new subsection (8) in this regard.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 123, SECTION 123.04(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO RAFFLES

BE IT ORDAINED by the President and Board of Trustees of the Village of Lombard, DuPage County, Illinois, as follows:

SECTION 1: That Title XI, Chapter 123, Section 123.04(A) of the Lombard Village Code is amended by adding a new subsection (8) thereto, which shall read in its entirety as follows:

"(8) The licensee shall prepare and maintain a written set of rules which are applicable to the conducting of the raffle, and shall provide said written rules to anyone who desires to purchase a chance, relative to said raffle, upon request."

SECTION 2: That his Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
