SUBJECT: Request for a Class "D-VG" Liquor License – Otto's Tavern

433 Crescent Boulevard

As you are aware the Village of Lombard Board of Trustees on April 4, 2019 approved video gaming for certain liquor license classifications by Ordinance 7647.

Mitchell & Daniel's, Ltd. d/b/a Otto's Bar & Grill located at 433 Crescent Blvd currently holds a Class "D" liquor license which allows the sale of alcoholic beverages served with the primary purpose of the establishment being a tavern.

Staff is currently in the process of renewing liquor licenses for the July 1 through December 31, 2019 liquor licensing term. Mitchell & Daniel's Ltd. d/b/a Otto's Bar & Grill has decided to voluntarily not renew their Class "D" license for the upcoming liquor licensing term and Mitchell & Daniels, Ltd. d/b/a Otto's Tavern applied for a new Class "D-VG" liquor license.

Attached is an ordinance amending Title XI, Chapter 112, Section 112.13(A) decreasing the number of entries in the Class "D" liquor license category by one and increasing the number of entries in the Class "D-VG" license category by one, effective July 1, 2019.

Staff is requesting a waiver of first reading due to the timing of the new liquor licensing term.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "D" liquor license, contained therein, to read as follows:

Class "D" - 1

This decrease in the number of Class "D" liquor licenses reflects the voluntary non-renewal of Mitchell & Daniel's, Ltd. d/b/a Otto's Bar & Grill located at 433 Crescent Blvd. for the July 1 through December 31, 2019 licensing term and the termination of the Class "D" liquor license issued to Mitchell & Daniel's Ltd. in relation thereto.

Section 2: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "D-VG" liquor license, contained therein, to read as follows:

Class "D-VG" - 2

This increase in the number of Class "D-VG" liquor licenses reflects the issuance of a new Class "D-VG" liquor license to Mitchell & Daniels, Ltd. d/b/a Otto's Tavern located at 433 Crescent Blvd., Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
