Ordinance Amending Title XI, Chapter 112, Section 112.13(A) - Alcoholic

Beverages - Kai Sushi - 2820 S. Highland Avenue

Taste of Asian Inc. d/b/a Kai Sushi currently holds a Class "C" liquor license which allows the sale of beer and wine with the primary purpose of the establishment being a restaurant.

Staff has been informed that the ownership interest in the corporation, Taste of Asian, Inc., has changed more than 50 percent. Village Code Title XI, Chapter 112, Section 112.20(D) states that a liquor license shall terminate whenever 50 percent or more of the ownership interest changes from that shown on the original license application. The new owners of Taste of Asian, Inc. have made application for a new Class "C" liquor license.

Attached is an ordinance decreasing and increasing the number of Class "C" licenses by one to reflect the ownership interest changes.

Staff is requesting a waiver of first reading to reflect these changes.

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor licenses, contained therein, to read as follows:

Class "C" - 7

This decrease in the number of Class "C" liquor licenses reflect a change in ownership of Taste of Asian, Inc. d/b/a Kai Sushi located at 2820 S. Highland Avenue, and the termination of the Class "C" liquor license issued to Taste of Asian, Inc. in relation thereto.

Section 2: That Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "C" liquor licenses, contained therein, to read as follows:

Class "C" - 8

This increase in the number of Class "C" liquor licenses reflects the issuance of a new Class "C" liquor license to Taste of Asian, Inc. d/b/a Kai Sushi located at 2820 S. Highland Avenue, Lombard, IL.

Section 3: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
