**Voluntary Non-Renewal of Liquor Licenses** 

In accordance with Village Code, liquor licenses are renewed on a semi-annual basis. Village staff is completing the renewal process for the July 1 through December 31, 2019 licensing term. Staff has been notified that the following liquor licensees will not be renewing their licenses for the upcoming licensing term:

- Jainson International Corporation d/b/a Viceroy of India located at 233 E Roosevelt Road
- Usmania Foods Inc d/b/a Shahi Banquets located at 530 E North Avenue
- Lom Ling Restaurant d/b/a Lom Ling Restaurant located at 108 W St Charles Road

## AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE TO REDUCE THE NUMBER OF AVAILABLE LIQUOR LICENSES IN THE CLASS "A/B-I", "K", "U" "VV" AND "Y" LIQUOR LICENSE CATEGORIES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

**SECTION 1**: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-I" liquor licenses, contained therein, to read as follows:

Class "A/B-I" - 7

**SECTION 2:** That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "K" liquor licenses, contained therein, to read as follows:

Class "K" - 2

SECTION 3: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "U" liquor licenses, contained therein, to read as follows:

Class "U" - 1

SECTION 4: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "VV" liquor licenses, contained therein, to read as follows:

Class "VV" - 0

**SECTION 5:** That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13 (A) of the Lombard Village Code is amended by revising the entry relative to the Class "Y" liquor licenses, contained therein, to read as follows:

Class "Y" -0
