ORDINANCE ____

AN ORDINANCE AMENDING TITLE XI, CHAPTER 112, SECTION 112.13(A) OF THE LOMBARD VILLAGE CODE IN REGARD TO ALCOHOLIC BEVERAGES

BE IT ORDAINED BY THE PRESIDENT AND BOARD OF TRUSTEES OF THE VILLAGE OF LOMBARD, DU PAGE COUNTY, ILLINOIS as follows:

Section 1: That, effective July 1, 2019, Title XI, Chapter 112, Section 112.13(A) of the Lombard Village Code is amended by revising the entry relative to the Class "A/B-II-VG" liquor license category, contained therein, to read as follows:

Class "A/B-II-VG" - 1

This increase in Class "A/B-II-VG" liquor license reflects the issuance of a Class "A/B-II-VG" liquor license to Ramey's Bar and Grill LLC d/b/a Ramey's Bar and Grill located at 2370 Fountain Square Drive, Unit B, Lombard.

Section 2: This Ordinance shall be in full force and effect from and after its passage and approval as required by law.
