RE: Awarding Landscape and Parkway Restoration Contract

On November 22, 2018, the Village of Lombard advertised for bids for the Village contract **PWO 19-17B**, *Parkway*, *Turf*, *and Landscape Restoration*. Bid packets were sent to 13 landscape maintenance companies. The bid opening was held on December 7, 2018 with three (3) bids being received. *TNT Landscape and Construction, Inc.* was the awarded the contract as the low bidder.

TNT Landscape and Construction, Inc. completed a portion of the work assigned to them before the weather forced them to shut down. They have not had a crew in town since May 17, 2019. After repeatedly requesting a schedule from the current landscape restoration contractor (TNT Landscape and Construction, Inc.) to perform the completion of restoration work in accordance with the contract, the Village Public Works Department received notification that TNT Landscape and Construction, Inc. would be unable to have a crew in the Village to complete outstanding work from April, May and June until mid to late August. The Village will seek to terminate the contract with TNT and apply any and all penalties under the contract.

The Village Public Works Department has reached out to the second lowest responsible bidder (*Uno Mas Landscaping*) see if Uno Mas Landscaping would assume the contract and perform the outstanding restoration work as well as any new restoration work going forward. *Uno Mas Landscaping* has agreed to honor their bid prices for parkway restoration work.

Uno Mas Landscaping was the second lowest responsible bidder. Uno Mas Landscaping has done parkway restoration work for the Village in the past and the work has been acceptable. Fiscal year 2019 budget contains \$70,000.00 for landscape and parkway restoration of which \$33,000 is encumbered for the contract with our primary restoration contractor.

Staff recommends terminating the current contract with *TNT Landscape and Construction*, *Inc.* and awarding a new contract to *Uno Mas Landscaping* in an amount not to succeed \$49,950.00 for landscape and parkway restoration. This is a 5-month contract starting in August 2019 and running through December 2019.

- 2. The Village agrees to pay, and the Contractor agrees to accept as full payment for the items, and installation of the same, which are the subject matter of this contract the total sum not to exceed \$55,000.00 paid in accordance with the provisions of the Local Government Prompt Payment Act.
- 3. The Contractor represents and warrants that it will comply will all applicable Federal, State and local laws concerning prevailing wage rates and all Federal, State and local laws concerning equal employment opportunities.
- 4. The Contractor shall commence work under this Contract upon written Notice to Proceed from the Village and shall complete work on this project as laid out in the restoration timeline once given the Notice to Proceed. Time is of the essence of this Contract and Contractor agrees to achieve completion within the contract time by all proper and appropriate means including working overtime without additional compensation.
- 5. Bonds required to guarantee performance and payment for labor and material for this work shall be in a form acceptable to the Village and shall provide that they shall not terminate on completion of the work, but shall be reduced to ten percent (10%) of the contract sum upon the date of final payment by the Village for a period of one (1) year to cover a warranty and maintenance period which Contractor agrees shall apply to all material and workmanship for one (1) year from the date of issuance of the final payment by the Village.
- 6. Pursuant to the provisions of Section 5 of the Mechanics' Lien Act of Illinois, prior to making any payment on this contract the Village demands that the Contractor furnish a written statement of the names of all parties furnishing labor and/or materials under this Contract and the amounts due or to become due on each. This statement must be made under oath or be verified by affidavit. Final payment shall not be issued by the Village nor shall any retained percentage become due until releases and waivers of lien have been supplied as the Village designates.
- 7. In executing this Contract, Contractor agrees that it has examined the site of the work and the conditions existing therein, has examined the Contract Documents and taken and compared field measurements and conditions with those Documents.
- 8. This Contract represents the entire Agreement between the parties and may not be modified without the written approval of both parties.

**Subject:** Termination of Contract - TNT Landscape Construction, Inc.

The Village of Lombard (the Village) entered into a contract (PWO 19-17b) for parkway and landscape restoration services with TNT Landscape Construction, Inc. (the contractor) on January 3-2019. The contract called for the monthly restoration of utility dig and stump removal sites. The Village was to send the contractor lists on a monthly basis which the contractor would then restore by the deadline which was included on the lists, approximately one month from date of issue.

Below is a synopsis of the communications between the Village and the contractor:

March 29, 2019 - Village emails Contractor first set of lists with a May 1, 2019 due date.

April 1, 2019 - Contractor replies PennMulch is on back order and they will be in town in a few weeks. Village acknowledges reply.

April 10, 2019 – Village provides Contractor with updated copy of restoration letter to provide to residents at restored sites.

April 22, 2019 - Contractor emails seeking clarification as to which sites get PennMulch. Village replies all sites get seed and PennMulch.

May 1, 2019 – Village emails contractor list of sites to be restored in May (May 31, 2019 due date). Contractor emails Village that lists are not finished and seeks an extension to mid-May. Village agrees to an extension for the April lists until May 17, 2019.

May 14, 2019 – Village emails Contractor to advise of an incorrect address on April lists. Contractor emails Village seeking additional stump grinding at 641 S Stewart Avenue. May 17, 2019 – Village emails asking for estimated completion date for utility dig site at 500 N Charlotte.

May 20, 2019 - Contractor replies "Hopefully this week", comments that weather just hasn't improved.

May 27 – 31, 2019 – Village inspections of restoration April sites for completion. Three of 38 Utility dig locations and 40 of 97 stump locations had been completed from April lists. No activity on May lists.

May 31, 2019 – Village requests plan from Contractor on getting caught up. April lists not done and May not started. Contractor replies "Honestly no clue." It has been three weeks since they've been able to get topsoil. Hoped to have answer from topsoil provider on Monday, June 2. Village advised that sending June list would be delayed by about a week.

June 3, 2019 - Village emails asking about topsoil/schedule.

June 4, 2019 - Contractor replied schedule was to finish April lists second week of June, May lists third week of June, June lists last week of June.

June 7, 2019 – Village emails Contractor that stump at 641 S Stewart has been ground further and is ready for restoration.

June 14, 2019 - Village emails Contractor stump list for June to be restored by July 12, 2019.

June 17, 2019 – Village emails Contractor advising them of a dirt field located in Lombard if they are still having trouble getting soil.

June 24, 2019 - Village inspects sites and determines no additional work has been completed.

June 27, 2019 – As no additional progress had been made on any of the restoration lists, Village sends certified letter advising contractor significant completion required on outstanding work by July 12, 2019.

July 3, 2019 USPS leaves notice for pick-up of certified letter.

July 15, 2019 – No progress has been made on outstanding work. Village emails inquiring contractor's intentions as no work has been performed in two months. Contractor replied that they will not be able to perform any restoration work until the middle or end of August. Contractor advises "If you have to hire someone else to bring the work current then please do so."

July 16, 2019 - Village requests Contractor submit invoices for work which has been completed.

July 22, 2019 - Contractor has not yet picked up certified letter.

Dear Mr. Terlecki,

As of this date, TNT Landscape Construction, Inc. has failed in the timely completion of landscape restoration work assigned under contract PWO 19-17B. The Village has sent three work orders (Apr 2019, May 2019, and June 2019) which TNT has failed to complete in accordance with the contract. Work was started on the April lists and an extension granted until May 17th for completion of the April lists due to weather delays. The majority of the April stumps were restored in late April and early May but no work has been performed since mid-May on any of the remaining lists.

Unless the remaining outstanding work is completed by July 12<sup>th</sup> the Village will take steps to terminate the contract and seek a new contractor to complete the past due work and any future parkway restoration work this year. The Village will be seeking reimbursement of any cost differences through the performance bond which was posted for this contract.

Please provide us with a time table if you plan on completing the work under this contract. If you can no longer complete your obligations under this contract please let us know so that arrangements can be made to bring another contractor in to complete the work and assume the contract for the remainder of the year.
