BACKGROUND/POLICY IMPLICATIONS:

The 2019 property tax levy was presented to the Finance & Administration Committee at their meeting on September 23, 2019. The staff report on the Statutorily Permissible 2019 Tax Levy is attached. Below is the general overall summary of the tax levy:

It is estimated that new growth will account for 1.81% of the increase in the levy. If there is no new growth, there will be no levy for this.

Based on the total estimated EAV along with the number of households in Lombard per the most recent census, the Village's share of the tax bill for the average \$189,000 household is expected to increase approximately \$8.42. For the owner of a \$300,000 house, the increase will be approximately \$14.21.

The Finance & Administration Committee, at their meeting on September 23, 2019, voted unanimously to recommend the statutorily permissible 2019 tax levy to the President and Board of Trustees.
