REPEAL OF VIDEO GAMING FROM JUNE 30, 2020 TO DECEMBER 31, 2020

Attached please find the following proposed ordinance:

An Ordinance Amending Ordinance No. 7647, Adopted April 4, 2019, Entitled, "An Ordinance Amending Title XI, Chapter 110, Section 110.11; Title XI, Chapter 112; and Title XI, Chapter 115 of the Lombard Village Code in Regard to Video Gaming and Liquor Licenses for Establishments with Video Gaming."

On April 4, 2019, the Village Board of Trustees approved an ordinance which amended the Village Code to permit and regulate video gaming on a temporary basis within the Village of Lombard. The ordinance provided that effective 11:59:59 p.m. on June 30, 2020, without further action of the Village Board, the ordinance would automatically be repealed. The proposed ordinance would amend the date of automatic repeal from June 30, 2020 to December 31, 2020.

This amendment is proposed in connection with the proposed ordinance which repeals the March 17, 2020 advisory public question concerning video gaming and sets a date for consideration of an ordinance placing the same question on the November 3, 2020 ballot after March 17, 2020 and before August 16, 2020 (Legistar #190480).

SECTION 2: That Section 15 of Ordinance No. 7647, adopted April 4, 2019, is hereby amended as follows:

- A. The references therein to "June 30, 2020" are hereby revised to read "December 31, 2020"; and
- B. The references therein to "July 1, 2020 to December 31, 2020" are hereby revised to read "January 1, 2021 through June 30, 2021".

SECTION 3: That Section 16 of Ordinance No. 7647, adopted April 4, 2019, is hereby amended by revising the reference therein to "June 30, 2020" to read "December 31, 2020".

SECTION 4: That all other provisions of Ordinance No. 7647, adopted April 4, 2019, not amended hereby, shall remain in full force and effect.

SECTION 5: That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form, as provided by law.
